- Additional children may be added to a membership for \$30 per child (for residents) or \$40 per child (for nonresidents). Payment must be made upfront for additional children.
- Senior Couple consists of two individuals 60 or older, living in the same household.
- To cancel your pass, you will need to complete the Pass Cancellation Form. You will be subject to pay a \$25 cancellation fee.
- Annual Passes can only be canceled with medical documentation from a physician or proof of new residency outside of Wentzville.
- A \$15 fee will be charged when any check, credit or debit payment is declined.
- There is a \$5 fee for any lost or stolen card.
